ORDER:-

As per the special rules for the Andhra Pradesh Educational Subordinates Services issued in the Government Order 2nd 1st read above, and as amended subsequently in the Government Order 2nd read above, the Physical Directors in the Junior Colleges are required to possess B.A./B.Com./B.Sc. Degree plus a degree or Diploma in Physical Education. The question of prescribing Master's Degree qualification in Physical Education for Physical Director's in Junior Colleges with references to the recommendations of the P.R.C. 1986 and the representation made by the A.P. State Jr. College Physical Director's Association in the reference 3rd read above has been under the consideration of the Government for sometime. The matter has been carefully examined with reference to the recommendations of the P.R.C. 1986.

2. After consideration, Government have decided to prescribe the following qualifications for the existing incumbents and for future recruits of Physical Director in the Junior Colleges.

For the existing Physical Directors:

"Post Graduate Degree (M.A./M.Com./M.Sc.) with a Degree/Diploma or a certificate in Physical Education".

For the future recruitment to the posts of Physical Directors:

"Degree in any faculty plus M.P.Ed. Ist. or 2nd class with not less than 50% marks.

3. Government direct that the individuals who possess the qualifications prescribed in para 2 above shall be allowed the scale of pay of Rs. 1550-3050/- with effect from the date of issue of these orders.

4. Necessary amendments to the A.P. Educational Subordinate Services rules will be issued separately.
